- B. District Data and Finance: Dr. Boyer updated the Board on the financial status of the district at the close of the 2022-2023 school year.
- C. Cell Phone Policy 2022-2023 School Year: Reba Green made a motion to ban all cellular devices, including watches, from classrooms, passing periods, only allowing during lunch. Courtney Gunter seconded the motion. Three voted in favor and three voted against. The motion failed.

Robbie Letterman made a motion to ban use of all cellular devices, including earbuds, not to be seen or heard during class times. Kevin Dampier seconded the motion. The motion passed 4-2.
